The quotation must be on letterhead of your business and be hand-delivered in the TENDER BOX not later than the <u>22 August 2024 at 12h00</u> at Thabo Mofutsanyana District Municipality (Old Parliament building).

The following conditions apply:

- Prices quoted must be valid for at least (30) days from the date of your offer.
- Prices quoted must be firm and should clearly indicate whether they are VAT inclusive or VAT exclusive.
- NB: Please indicate the period of delivery on your quotation which should be regarded as binding if you win this award.

Mandatory documents to be submitted:

- Central Supplier Database (CSD) Report or MAAA number of the bidder.
- Tax Clearance Certificate (TCC) or Tax Compliance Status PIN of the bidder.

- Copies of bidders' Identity Documents
- Municipal account/ Municipal clearance certificate.
- BBBEE Certificate
- CK

Municipality will not make an award to any bidder/ supplier under the following:

- If the bidder is not registered in the Central Supplier Database (CSD)
- If the bidder owes a municipality's utility bill for more than 90 days and there is no proof of arrangement made with the municipality to rectify the situation.
- If the bidder is prohibited to transact with any organ of state
- If the bidder's tax matters have not been declared by SARS to be in order and there is no proof of arrangement made with SARS to rectify the situation.
- If supplier is a natural person, he/ she is in the service of the state.
- If supplier is not a natural person, any of its director, manager, principal shareholder, or stakeholder a person in service of the state.
- If a supplier is an advisor or consultant contracted with the municipality

The quotations will be evaluated according to the criterion below as prescribed in the Preferential Procurement Policy framework Act No 5 of 2000 and provided for in the Municipality's Preferential Procurement Policy.

NB: No quotation will be considered from persons in the services of the state.

Failure to meet the above conditions and failure to submit the required documents may invalidate your bid/ tender.
